

Terms and Conditions

1. 500 AIR MILES Bonus Miles offer is limited to new BMO Sobeys AIR MILES Mastercard accounts. Applications must be received by March 31, 2018. You must make a first card purchase with your BMO Sobeys AIR MILES Mastercard in order to receive the one time 500 Bonus AIR MILES Reward Miles. Existing BMO Sobeys AIR MILES Mastercard accounts and those who cancel their account during the offer period are not eligible. Limit of one (1) offer per AIR MILES Collector Account (Collector Account). The Bonus Miles will be applied to your Collector Account within forty-five (45) days after your first card purchase. If you cancel your card within thirty (30) days of opening your account, the Miles will be cancelled. Your credit card account must be in good standing when the Bonus Miles are awarded. This offer may be changed, extended or withdrawn at any time without notice.

If you cancel your card within thirty (30) days of opening your account, all Miles earned within that thirty (30)-day period will be cancelled. This offer is subject to change or cancellation at BMO/Sobeys' discretion upon thirty (30) days' prior notice to the cardholder.
